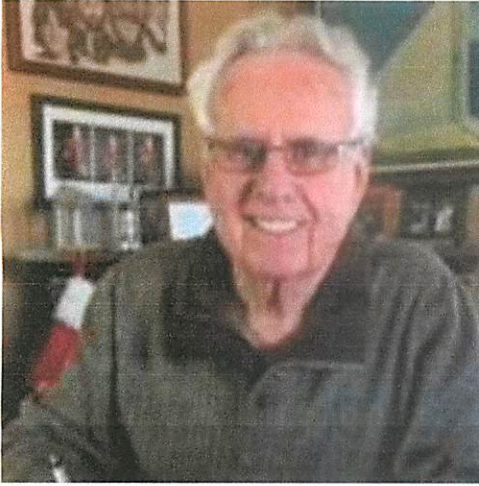




What's Up With Bill Mullen (5)

Bill's Time Bomb

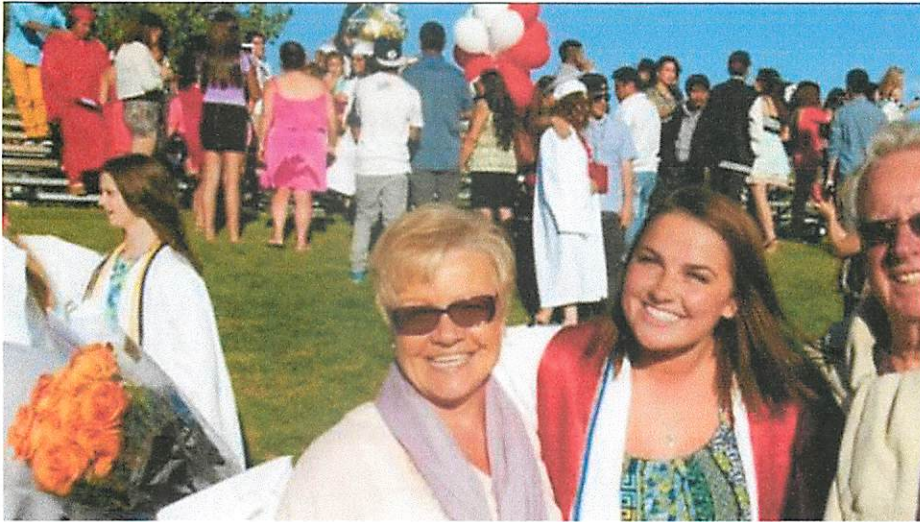
No stranger to a small-town scene, since there were only 24 in his high school graduating class, Park City seemed like a good match. *"Since 1995 I have managed my Financial Planning firm here in Park City."*

He has also written and published his first book; **The Tax Ticking Time Bomb; How to Recognize & Manage Tax Traps in Retirement.**

Over the years, Bill's research has shown that most people have saved for retirement using tax deferred accounts like IRAs & 401(k)s. *"In many cases, they do not consider that all the money in those accounts does not belong to them. A quarter to a third of the money will have to be used to pay taxes. Using tax deferred accounts is a good way save for retirement. It is not a good way to enter retirement with all your money in tax deferred accounts. Helping clients reposition assets as they approach retirement has been my focus since publishing that book."*

Bill had great help from three locals in getting the book written and published. *"Make that four when I include my wife Carole. Stacy Dymalski (she has since moved to LA) educated me on how to self-publish and she proof read the draft. I thought I was a grammarian before Stacy. I still use what I learned from her when I write now. Michelle Rayner did a great job on the graphics and Katie Mullaly (14) put it all together so that it could be published. Without those three, it would not have come together in 7 months."*
